Formal written price quotations are hereby requested from competent and reputable service providers for replacing electrical automated meters in Bultfontein and Hoopstad

1. Introduction

This bid document outlines the requirements and scope of work for replacing electrical automated meters in Bultfontein and Hoopstad. The objective is to enhance the efficiency, accuracy, and reliability of electricity metering in these areas.

2. Project Overview

The project involves removing outdated electrical meters and replacing them with modern automated metering infrastructure (AMI). This upgrade aims to facilitate remote monitoring, improve data accuracy, reduce operational costs, and enhance customer service.

3. Scope of Work

The scope of work includes but is not limited to:

- **Site Assessment:** Conduct a thorough assessment of existing meter installations in both Bultfontein and Hoopstad.
- **Meter Procurement:** Tswelopele Local Municipality will supply high-quality automated meters that meet industry standards.
- **Installation:** Remove old meters and install new automated meters at designated locations.
- **Testing & Commissioning:** Perform functional tests on all newly installed meters to ensure they operate correctly.
- **Data Integration:** Integrate new meters into the existing billing system for seamless data transfer.

- **Training:** Train local utility staff on operating and maintaining the new metering systems.
- **Documentation:** Deliver comprehensive documentation including installation manuals, warranty information, and maintenance guidelines.

4. Functionally Requirements

To ensure successful implementation, the following functionalities are required from the installer installing the automated meters:

- The installer must be a qualified electrician and registered Industrial Electrician (wireman's license).
- Grade 4 Metering Technician as per metering code of practice (NRS 057 – 1).
- Experience Technician to install and commissioning Automated meters and modems.
- Capability to record load profiles over time for analysis of consumption patterns.
- An interface that allows easy access to data by both utility staff and consumers.

5. Timeline

The project is expected to follow this timeline:

- Installation: 4 weeks
- Testing & Commissioning: 2 weeks
- Training: 1 week

6. Budget Estimate

A detailed budget will be provided upon completion of site assessments; however, preliminary estimates should include:

Quote will be evaluated in terms of section 5, read with section (2) (1)(b)(1) of the preferential Procurement Policy Framework act,2000 with the following criteria, the points will be used to supplement BBBEE together with Preferential Procurement Regulations,2022 and Tswelopele Local Municipality Preferential Procurement Policy.
4. The Relevant MBD 4 forms **must** be completed and submitted with the quotation, which can be downloaded from the municipality's website [www. tswelopele.gov.za](http://www.tswelopele.gov.za) –Declaration of interest. Quotations without signed Declaration of interest will not be considered.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

CERTIFICATE OF INDEPENDENT BID DETERMINATION

1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.

2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a pe se prohibition meaning that it cannot be justified under any grounds.

 - (d) the intention or decision to submit or not to submit, a bid;
 - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or

(f) bidding with the intention not to win the bid.

8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.

9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
