Formal written price quotations are hereby requested from competent and reputable service providers for training for pothole patching programme for 12 municipal employees at Technical Section on road construction, maintenance and rehabilitation at Tswelopele Local Municipality area of jurisdiction.

1. Introduction

This bid document outlines the requirements and scope of work for training for pothole patching programme for 12 municipal employees at Technical Section on road construction, maintenance and rehabilitation in Tswelopele Local Municipality. The objective of the training is to teach practical fundamentals of road construction, pavement assessments, technical aspects of materials, the surfacing of roads, distress identification and repairs as well as road furnishing.

The training will also upskill the 12 employees on the new technology and sustainability of roads, and the safety issues surrounding all these processes.

2. Project Overview

The project involves training on practical fundamentals of road construction, pavement assessments, technical aspects of materials, the surfacing of roads, distress identification and repairs as well as road furnishing.

The training provider is also expected to provide a training manual which can be utilized as a refresher course for the supervisors who previously attained the skill including for future use by the employees to be trained.

3. Scope of Work

The scope of work includes but is not limited to:

- **Introduction to Roads** – A brief history of road building, Preconditions for road building and maintenance, Road manuals (TRH, TMH And UTG documents) including glossary and applicable abbreviations.
- **Pavement Assessments and Investigations** – Field investigations, Compilation of data, Analysis, Safety aspects of materials, Basic material mechanics, Quality assurance and testing including Effect of weather on roads.
- **Types Of Plant and Equipment including aspects of materials and roads** – Small plant and tools, Earthmoving equipment including Types of materials for construction and maintenance.
- **The Construction Process** – Reading from plans and drawings, Visual assessment, Clearing and grubbing, Earthworks, Layer works, Services, Confined and restricted areas, Water handling and Drainage.
- **Surfacing Roads**- General, surface seals, another surface types and reseals
- **Distress Identification and Repairs** – Distress types, Cracks, Crack sealing, Potholes and patches, Deformation, Rigid defects, Surface enrichment treatments including Shoulder maintenance.
- **Road Furnishing and Ancillary Works** – Road Signs, kerbing, Minor Concrete Works, Erosion Protection, Guardrails and Finishing, Drainage Maintenance, Structure Maintenance, Traffic Facilities Maintenance and Road Reserve Maintenance.
- **New Technology and Sustainability** – New Technology, Sustainability, Rehabilitation and Recycling.
- **Road Safety And OHSACT** – Safety and Traffic Management.

4. Functionally Requirements

To ensure successful implementation, the following functionalities are required from the training facilitator:

- Each training provider must be accredited as a provider with the Construction Education and Training Authority - CETA (Attach proof).
- The provider must have at least one year experience in offering the same services. (Attach reference letters with appointment letters from the previous client)
- A copy of the accreditation certificate and statement from the CETA-ETQA specifying the areas of accreditation must be attached to the proposal.
- A copy of the accreditation's statements and CVs for the facilitators must be attached.

- The training provider must issue a certificate of attendance after one month of training and certificate of competency after 4 months completion of training.
- The training provider must submit proof of uploading learners on the National Learners Records Data Base (NLRDB) before commencement of the training.
- A detailed close-out report for the work done should be submitted at least one week after completion of the training to the Human Resources Development Officer.
- The training provider must submit proof of learner enrolment before completion of the training.

5. Timeline

The project is expected to follow this timeline:

- Training: 1 week (within 5 working days)

6. Budget Estimate

A detailed budget will be provided upon completion of site assessments; however, preliminary estimates should include:

- The training manual for each learner plus an overhead projector.
- The training will be in-house training meaning it will be within the Tswelopele Local Municipality area of jurisdiction,
- The training provider must provide travelling, accommodation, and meals (Dinner Bed and Breakfast) for the facilitator.
- The target group for this programme are 12 Technical Services personnel.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.

2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a pe se prohibition meaning that it cannot be justified under any grounds.

3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:

b. cancel a contract awarded to a supplier of goods and services if the supplier committed any corrupt or fraudulent act during the bidding process or the execution of that contract.

4 This SBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.

5 In order to give effect to the above, the attached Certificate of Bid Determination (SBD 9) must be completed and submitted with the bid:

¹ Includes price quotations, advertised competitive bids, limited bids and proposals.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.
