Formal written price quotations are hereby requested from competent and reputable service providers for mSCOA Budgeting Compliance and reconciliation of financial records for 2025/20256 MTREF.

1. Introduction

Tswelopele Local Municipality invites suitably qualified and experienced service providers to submit FWPQ for services of a performing a comprehensive financial analysis and reconciliation on the 2025/2026 draft budget, as well as performing a fully compliant mSCOA 2025/2026 MTREF and skills transfer.

2. Scope of Work

The successful service provider will be required to perform the following tasks:

1. Budget Segmentation: Conduct a thorough analysis to ensure that all relevant segments are budgeted for.
2. *Treasury Assessment*: Conduct a thorough analysis on the Draft Budget 2025/2026 to address all Provincial Treasury assessments findings related to discrepancies between budgets, mSCOA segment compliance, and any other discrepancies identified in the Draft Budget.
 - Assess, investigate, and correct misalignment of balance sheet data strings identified in the draft budget.

- Balancing DORA allocation to budget.
- 3. Balance Sheet Budget Review: Review the balance sheet budget segment, identify segments causing cash flow imbalances, and recommend adjusting entries.
- 4. Application of costing segment in the final budget.
- 5. Opening Balances Reconciliation: Ensure that all opening balances are accurately reflected in the system and reconcile with historical data.
- 6. Budgeting for VAT in final budget.
- 7. Producing a fully mSCOA compliant Final Budget for 2025/2026.
- 8. Producing a reconciled A-schedule to the data strings.
- 9. Skills Transfer: Perform skills transfer to relevant personnel.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

CERTIFICATE OF INDEPENDENT BID DETERMINATION

1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.

2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a pe se prohibition meaning that it cannot be justified under any grounds.

3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:

Bid rigging is, therefore, an agreement between competitors not to compete.

6. The bidder has arrived at the accompanying bid independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium³ will not be construed as collusive bidding.

7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:

- (a) prices;
- (b) geographical area where product or service will be rendered (market allocation)
- (c) methods, factors or formulas used to calculate prices;

8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.

9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.
