Formal written price quotations are hereby requested from competent and reputable service providers for the servicing of transformers, repair of oil leaks, and maintenance of T3 and K3 switchgear as per list in Bultfontein and Hoopstad.

Specifications as follows:

1. Introduction

Tswelopele Local Municipality invites qualified and experienced service providers to submit bids for the servicing of transformers, repair of oil leaks, and maintenance of T3 and K3 switchgear across various substations within the municipality's jurisdiction. This project aims to ensure reliable power distribution, enhanced equipment lifespan, and compliance with safety and operational standards.

2. Scope of Work

The scope of work for this bid includes, but is not limited to:

- **Transformer Servicing:**
 - Routine maintenance and inspection.
 - Cleaning, lubrication, and adjustment of components.
 - Oil sampling and dielectric, Dissolve Gas, and PCB testing for predictive maintenance.
 - Only Virgin Oil shall be used in Transformers and Ring Main Units.

- **Oil Leak Repairs:**
 - Identification and sealing of oil leaks.
 - Replacement of gaskets and oil drain plugs where necessary.
 - Ensuring proper oil levels and quality checks.
 - Environmental management of oil disposal per regulatory guidelines.

- **T3 and K3 Switchgear Maintenance:**

- Visual inspection for signs of wear and damage.
- Testing of circuit breakers and control mechanisms.
- Cleaning of busbars, contact points, and panels.
- Functional testing and operational verification.
- Replacement of Oil and faulty components where necessary.

3. Mandatory Requirements

All bidders must comply with the following:

- Valid company registration and compliance certificates.
- Proof of experience in electrical maintenance and substation servicing.
- Certified personnel for high-voltage maintenance and repairs.
- Compliance with local and national safety regulations (e.g., SANS, NRS standards).
- Valid B-BBEE Certificate.
- Environmental management plan for oil disposal.

2. Quote will be evaluated using returnables, Functionality, Preference Points (100 points) and PPPF– Price (80) and Specified Goals (Race, Gender, Disability and Youth) (20)
3. Quote will be evaluated in terms of section 5, read with section (2) (1)(b)(1) of the preferential Procurement Policy Framework act,2000, Preferential Procurement Regulations,2022 and Tswelopele Local Municipality Preferential Procurement Policy.
4. The Relevant MBD forms **must** be completed and submitted with the quotation, which can be downloaded from the municipality’s website [www. tswelopele.gov.za](http://www.tswelopele.gov.za).
5. Quotations without signed MBD Forms will not be considered.

8. Bidders who do not have a Vat registration and are not registered for Vat, must not split the VAT Portion amount from the grand total, for such the Municipality will consider total before Vat as the bidder is not eligible to charge VAT.
9. **The Municipality will not allow any additional cost or price increase after an award of the quotation.**
10. Accounting Officer reserves the right to not make an appointment on an advertised request for quotation.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

CERTIFICATE OF INDEPENDENT BID DETERMINATION

1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.

2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a pe se prohibition meaning that it cannot be justified under any grounds.

7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
 - (a) prices;
 - (b) geographical area where product or service will be rendered (market allocation)
 - (c) methods, factors or formulas used to calculate prices;
 - (d) the intention or decision to submit or not to submit, a bid;
 - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
 - (f) bidding with the intention not to win the bid.

8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.

9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
